Compulsory Registration Scheme is operated under Bureau of Indian Standard (Conformity Assessment) Regulation, 2018 (Scheme II of Schedule II), as per the BIS Act 2016. The Scheme aims to provide momentum to the rapidly expanding sectors of Electronic & IT, while simultaneously protecting Indian consumers from spurious and substandard products. It has upgraded the competitiveness of domestic manufacturers and given Indian Consumers the right to enjoy world class quality-compliant goods. This strategy adopted by the Government of India has helped in preventing the dumping of non-complaint goods and bridged the gap between People, Technology and Safety.



The Compulsory Registration Order (CRO) forte is that no entity shall manufacture or import or sell or distribute goods which do not conform to the specified Indian Standard and does not bear the Standard Mark.

Who can apply for CRS?

- Manufacturer (factory owner) of any product, which comes under the ambit of the Compulsory Registration Order (CRO) notified by Ministry of Electronics and Information Technology (MeitY) or Ministry of New and Renewable Energy (MNRE).

Steps involved in Registration

- Obtain Login credentials
- Generate Test Request
- Submit Sample to Lab
- Apply on portal on receipt of confirmation (Release of Test Report online).

How to obtain login credentials?

- Go to https://www.crsbis.in/BIS/
- Upload Business License in English (Copy of certified translation is required, if the document is in foreign languages), establishing the name and address of the factory and indicating manufacturing activity in its scope. Additional document such as Management Systems Certificate can be accepted for establishing manufacturing activity.
- Get link on email id for verification.
- Verify your email by clicking on the link.
- Login request is approved after online verification of documents.

How to generate Test Request and select available Laboratory?

- Login using existing credentials.
- Enter Sample details.
- Select any approved Laboratory from the list.
- Await for confirmation from the selected Laboratory.
- Additional Step In case of non-availability of selected Laboratory, select any other approved Laboratory.
- Print the Test Request with QR code.

How to submit the Sample?

- Display/Paste the QR code on the sample/ packet to lab for easy scanning along & submit with a copy of test request.
- Send Sample and Test Request within 60 days of generation of Test Request to the Laboratory.
- On acceptance by the Laboratory, an acknowledgement is sent on registered email.
- Receive notification from Laboratory on completion of test along with Test report Number.

How to apply for license online?

- Login using existing credentials.
- Select Test Request Reference in alphanumeric form (this will upload the Test Report)
- Submit Undertaking regarding declaration of conformity
- Pay the required fee and generate an acknowledgment slip.
- Fill in the required details.
- Receive an acknowledgment on successfully completing & submitting all details.
- Send Affidavit by post to Registration department.

How to reset Login ID/Password?

- Pay the fee.
- Email request for reset with letter from Manufacturer on their letter head.
- Get the link on registered email id and reset the credentials.



How to apply for Inclusion(s)?

- Login through existing credentials.
- Follow the instructions given in "How to generate Test Request and select available Laboratory"?
- On receipt of information from Laboratory, apply online giving reference to Test Report.
- Submit Undertaking regarding declaration of conformity
- Submit fee through online payment gateway and Generate the Inclusion ID.
- Any change in existing details, i.e, change in name, address, AIR, etc will be accompanied by a fee along with required details.

How to apply for Renewal(s)?

- Login through existing credentials.
- Fill the online renewal application & upload the the required documents.
- Pay the required fee and generate receipt.
- On renewal, generate and download the renewal certificate.

How to apply for change of AIR?

- Login, fill necessary details and upload supporting documents.
- Pay the required fee and generate a receipt
- Submit Affidavit to Registration Department
- AIR details get updated.
- The entire request is required on the company's letter head.

How to request for other changes?

- Login with your existing credentials.
- Go to 'Profile update'.
- Select appropriate option.
- For name/address change, upload Business License in English (Copy of certified translation is required, if the document is in foreign language).
- Upload supporting documents on company letter head.
- Upload appropriate documents for other request.
- Pay the required fee & generate receipt.

How to update Critical Component List (CCL)?

- Login with your existing credentials.
- Go to CCL Update.
- Upload relevant Test Report after due verification.
- Submit Undertaking regarding declaration of conformity.
- Pay the required fee and generate a receipt
- Critical Component List is automatically placed on record.
- Get an acknowledgement by email.

How to withdraw Models?

- Login using your existing credentials.
- Go to 'Model Withdrawal'.
- Select the registration for which you want to withdraw the models.
- Select the models you want to withdraw.
- Pay the required fee and submit.
